KENTISBEARE PARISH COUNCIL

The minutes of a meeting of the Parish Council held on 14th April 2015 in Kentisbeare Village Hall at 7.30pm.

44/04/15. To accept apologies for absence. Cllr. Mrs Reed.

45/04/15. Declaration of interest in items on the agenda. Cllr. R Shore-Quinain (DPI as spouse) Clerk's salary and review. Cllr. C McIntyre (DPI as invoice submitted by himself) cheque no: 1329.

46/04/15. To confirm the minutes of the Parish Council meeting held on 10th March 2015. It was resolved to adopt the minutes as a true record of the meeting and they were duly signed by the Chairman.

47/04/15. Matters arising from the minutes not already covered by the agenda. None.

It was resolved to take the agenda item 6 (c) "MDDC Local Plan Review Proposed Submission (extension): To agree on a response", before Highways.

48/04/15. MDDC Local Plan Review Proposed Submission (extension regarding response). Whilst it is appreciated that the District Council are required to allocate sites within the district, it is considered that the current proposal, being for 50% of these sites to be allocated in Cullompton, is unacceptable. The Parish Council has significant concerns in relation to the lack of infrastructure and the numerous problems that this will cause. A response detailing these concerns will be made and will include a request that the allocation at Cullompton be reduced by around half and the balance sited elsewhere. The Parish Council will request that Junction 27 is re-considered. Before any support is given to any development at Junction 28, the Parish Council insist that immediate improvements are made to the current infrastructure.

Berry has reported a pothole near Aller Cross. The bank has been washed away opposite Silver Wood (W15797500). The surfaces of the following roads are in need of attention: Yerris Road and Strawberry Hill. Horn Road has some potholes. b) Work at Pirzwell. The Clerk reported that a letter received from a parishioner regarding pending works at Pirzwell had been forwarded directly to the Neighbourhood Highways Officer for attention.
- c) Site visit near Hollis House. Cllrs. McIntyre and Berry reported on a recent site visit at Stoford Water with some representatives from the Highways Agency. The purpose of the visit was to discuss the possibility of a passing place being constructed opposite the private entrance to Hollis House, to deter vehicles from using the entrance to Hollis House as a passing place.
